### Safeway Renovation

Natalie Mattei from Safeway announced that the company has purchased the Monterey Blvd. property and they are committed to operating at that location long-term. A major expansion and upgrade will require closing the store for 9-12 months. It will be about two years from a draft design to start of construction. Construction could begin in early 2011.

## Prospects Good for MOU with CCSF on Soccer Field

City College's plans to replace its soccer field drew the SNA City College Committee to the August 14 meeting of the college's Board of Trustees. Committee members conveyed how important it was for neighbors to have some respite on the weekends from the hoards of car parking, loud stereo playing, fast-food-wrapper littering students we are inundated with every weekday.

SNA's representatives asked City College to enter into a Memorandum of Understanding (MOU) with the SNA that would limit the use of the new field to City College's teams and classes, with no use by outside youth soccer leagues on weekends.

While the new field will be smaller than the old one, it will still be a regulation-size field which is why the MOU is so important—a regulation-size field is desirable to youth leagues around the City. Board members appeared very sympathetic to our position.

At a meeting on August 22 with CCSF Interim Chancellor Don Griffin and other college officials at the office of Supervisor Sean Elsbernd, we learned that the new field will be six feet lower than its neighboring football field. CCSF will discuss possible safety implications of plans to close part of Marston Road with SFFD.

CCSF officials were confident that the Board of Trustees and faculty would agree with the MOU terms we are requesting. Provisions include no bleachers, no lights, no loudspeaker system, and use by CCSF athletic teams and classes that do not use amplified sound or musical instruments. Lick Wilmerding will use the field weekdays from 4:00-6:00. Saturday classes will be scheduled at specified hours such as 9:00 to 1:00. The field will be closed on Sundays. It will be fenced, gated and locked.

Interim Chancellor Griffin suggested that the "700 bungalows," the temporary classrooms erected on Havelock, be included in the MOU in terms of restricting their use so as not to create noise problems for the surrounding community. We hope the "interim period" in which Don Griffin remains Chancellor lasts a long time!

We hope to have the MOU in place by the time you receive your next SNA newsletter.

Thanks to all of you, including City College Committee members Chris Coghlan, Xavier Guerrero, Jane Hopkins, Mikhail Koutouzov and Azian Nurudin; SNA members David Tejeda and Bill Makarewicz who attended the CCSF Board meeting; and Clarence Weems, Jane Hopkins, and Marilyn and Frank Koehler, who wrote City College about the soccer field after the last SNA membership meeting.

You are the reason we will succeed in getting this MOU! ❖

# Neighbors Encouraged to Get Informed about SF School Board Race

If you are a public school parent, you know that school board members make vital decisions about your child's education. But if you don't have children in public school, you might not feel that the school board affects you. I believe, however, that all of us can recognize that the quality of our schools affects our city's civic life and economic health, now and in years to come. It's in all of our interest to evaluate the current candidates for the Board of Education, for they will oversee the education of San Francisco's future citizens.

Above all, school board candidates should be very familiar with the San Francisco Unified School District. Unfortunately, in the past, the school board has been used as a stepping-stone to higher office by candidates with more ambition than commitment to our schools. How engaged has the candidate been with our schools in the recent past? How knowledgeable is the candidate about the policies and procedures of our school district?

Here are two current issues facing the school board that candidates should be able to address:

**School Closure:** School closures and mergers will be up for discussion in the coming year because of the continuing need for the district to save money. This could have an immediate impact on our neighborhood. What will be the criteria used to select closure candidates? How will board members make the process more transparent and incorporate community input?

Achievement Gap: A troubling gap persists between the academic achievements of different ethnic and socioeconomic groups. How will board members work with parents, teachers, and administrators to ensure that all students reach a proficient level of achievement?

Two school board candidate forums will be held. The first will be on September 25 at Lincoln High School, 24th and Quintara, from 7:00-9:00 p.m., hosted by our District 7 Supervisor Sean Elsbernd and District 4 Supervisor Carmen Chu. The second is on October 7 at Everett Middle School from 6:00-8:00 p.m. and is sponsored by Chinese for Affirmative Action, SF School Volunteers, Support for Families and other community groups. Check out the school board candidates' websites for more detailed statements of their positions on these issues.

Make sure that your choices for the Board of Education on November 4 are educated choices. Our city depends upon it. ❖

## Reservoir Access Assured after CCSF Negotiations

Since the SNA first heard about the land swap and the development of the reservoir property on the west side of Phelan Avenue, maintaining access to the west side of the reservoir has been a chief concern. The site, owned by City College and the San Francisco PUC, was split North and South for years. The land swap allows for the development of a new performing arts center and a classroom building along Phelan Avenue. We have alerted CCSF about our concern for access to the west side of the reservoir and the berm that surrounds it and the need for it to be a protected right of way for community access.

I was extremely disappointed when I saw that our walkway was taken away during recent roadwork. Thankfully, after a flurry of emails and meetings, City College has agreed to place a 12' lighted path along the northern fence to allow for safe access to the western side of the reservoir. The projected date of completion is mid-January. In the meantime, please be careful while accessing this area via the new sidewalk along the parking area.

There is still work to be done regarding the issue. The path will eventually continue around the reservoir site and bring pedestrians back to the south end of Phelan. It is my hope that the southern side of the reservoir can be graded so that we can have a gentle slope along that route.

As in most issues facing the neighborhood, community involvement is essential in protecting what is most important to us. Being involved in the SNA is a certain way for your voice to be heard.

### Stash Your Garbage Cans

Storing garbage cans – the black, blue and green bins – on sidewalks is unsightly, an obstacle to pedestrians and a violation of the municipal code.

Cans may be placed on the sidewalk after 6:00 p.m. on the day before collection day. They **must** be removed from the sidewalk within 24 hours of collection. Cans **must** be stored out of sight.

The Planning Dept. will review the updated and amended Plan, Planning and Zoning Map Amendments, and present the Balboa Park Community Improvements Program. In addition, Friends of Geneva Office Building will announce the Task 1 Design Report.

This is the last community meeting the Planning Dept. has scheduled prior to plan adoption – be sure to attend to learn what type of development the city will support in this area adjacent to our Sunnyside neighborhood.


