#### Phelan Bike Lanes, Police Captain Mahoney, Code Enforcement

#### Bike Lanes on Phelan Heading for Approval

The planning process for installing bike lanes on Phelan is moving ahead. At the February SNA meeting, James Shahamiri of SFMTA described the project and asked whether residents preferred to lose 140 parking spaces or a travel lane in order to accommodate the lanes.

Attendees voted overwhelmingly for the option to remove a travel lane, but many asked why the bike lanes weren't being routed on the new Lee Avenue extension instead of Phelan. A number of objections were raised regarding greater traffic delays on Phelan.

James explained that the bike lanes will be part of a larger traffic calming effort on Phelan. The traffic calming is intended to slow vehicular traffic and make the street safer and more inviting for pedestrians and bicyclists. Raised median islands with left-turn pockets will be installed at intersections from Ocean Avenue to Judson Avenue, and bulb-outs and raised crosswalks will make it safer to cross Phelan, an important consideration as CCSF constructs more buildings on the west side of Phelan.

Approval of the lanes was expected at SFMTA's Board meeting June 7.

#### Capitan Daniel Mahoney Tapped to Lead Ingleside Police Station

In June, Captain Daniel Mahoney was named captain of the Ingleside Station.

She strongly encourages residents to report problems through the City's 311 service and note the reference number for the case. If the problem is not resolved, contact Jana's office with the reference number at 415-554-3968 or email jana.clark@sfgov.org. Her office is responsible for code violations including:

- Buildings Unsafe or illegal construction, plumbing, electrical or mechanical projects; seismically unsafe buildings
- Health Trash accumulation, illegal dumping, abandoned vehicles
- Housing Illegal units, no heat or water, insect or rodent infestation, building disrepair
- Planning Illegal construction, illegal auto repair and storage in homes

#### Safeway Project Making Way through City Planning Process

For the past year, Safeway has been shepherding the Monterey Blvd. store remodel project through the city environmental planning process. This process is coming to an end, since the city did not find any major objections to the project. On Monday, May 23, the SNA Safeway committee met with Natalie Mattei, the Safeway representative, to find out where the project stands, and we discussed some outstanding issues.

First, since Safeway is asking to remove part of the median strip on Monterey Blvd. to enable trucks to back into the loading dock, the city asked them to provide mitigation for this change. This mitigation may be improvements to medians on other blocks of Monterey Blvd. Neighbors are also concerned about the safety of pedestrians at the Foerster and Monterey intersection, so mitigation may also address traffic calming efforts at this intersection.

Second, since the project currently has a three-lane driveway leading to/from the rooftop parking that is wider than city code allows, the city asked Safeway to narrow the driveway. Safeway feels, however, that a two-lane driveway will cause more congestion and be more dangerous, and will apply for a variance for the wider driveway. We discussed various measures to alert cars and pedestrians to the wide driveway including flashing lighted signs, beeping alerts, special painted pavement and pavers.

Neighbors are also concerned about store hours and do not want the store to operate 24 hours. Natalie said that Safeway will apply for permission to operate 24 hours although they will agree to operate at the current hours under the conditions of approval of the permit.

The SNA Safeway committee will meet over the summer to prioritize any remaining areas of concern and draft a letter on behalf of the neighborhood to the planning commission about the project. Natalie expects that the project will be reviewed by the planning commission in October or November 2011, at which time the neighborhood will have a final opportunity for comment. Construction is expected to begin in January 2012 and last 10-12 months, during which time the store will be closed.

#### Parking Restrictions on Circular a Matter for Debate

Circular Avenue between Baden and Judson offers something rare in SF –parking in the evening and on weekends. That, along with lax enforcement of parking regulations, has at times resulted in junk vehicles and pickup trucks full of rubbish routinely parking in this area.

A concerned neighbor gathered signatures on a petition to restrict overnight parking and parking of over-height vehicles and the matter was the subject of a public hearing. At the hearing, and at SNA's May meeting, it became apparent that there's a difference of opinion about the proposed restrictions. Here are comments from those opposed to, and in favor of, the restrictions:

#### Statement in Opposition to Proposed Parking Restrictions

Our door-to-door canvass of neighbors resulted in unanimous opposition to the proposed loss of overnight parking on the east side of Circular, and surprise that this was being considered. The neighbors we spoke to saw the main problems as illegal refuse dumping and a few people who store large, unused vehicles that only move for street cleaning.

For some who work nights, parking on Circular is the only safe option. This ban will force more vehicles onto the already crowded adjacent streets and won't stop the dumping. Working together, we neighbors can brainstorm alternative solutions like better signage and street lighting, law enforcement and surveillance.

#### Statement in Favor of Proposed Parking Restrictions

There is a social theory known as the "broken window theory" which states that by replacing broken windows quickly, it discourages future acts of vandalism. This theory holds true for other acts such picking up litter on a regular basis or weeding overgrown lots.

As residents of Sunnyside are aware, there has been a dedicated group who over the past year has cleaned up Circular Ave. Previously, Circular Ave was a dumping ground for trash: mattresses tire, etc. No longer are there the daily calls to 311 to report illegal dumping. The simple act of cleaning up this median has had positive effect for our neighborhood.

However, the residents of Sunnyside are not realizing the full benefits of the "broken window theory" because of the oversized and dilapidated vehicles that inhabit Circular Ave. I support some form of parking restriction along Circular Ave. to clean up this last remaining bit of blight.

## Life on the Sunny Side

In 1987 we came to San Francisco from Michigan to live closer to my husband's parents. We drove around the city on several reconnaissance missions—where should we live? Then we discovered Glen Park, a quaint village with homes dotting the hillside that had a BART station.

We found a one-bedroom cottage nestled behind another house on Staples Avenue, walking distance to Glen Park. No one we knew had ever heard of our neighborhood, but it was love at first sight. In what was no more than a sand-box, we planted a prolific garden and grew tomatoes so big they broke the vines. Our two cats were safely away from the street in our garden oasis.

We woke up to the song of a nearby rooster, and planted fragrant Cecile Brunner climbing roses and a Meyer lemon tree. Our next door neighbor Taylor, a retired MUNI driver, liked to sit in his station wagon and listen to the radio. More than once he rang the doorbell to remind us that it was street cleaning day and time to move our car. Eight years later, we moved from the cottage to the house in front.

Around the same time, Taylor moved out and a younger man moved in. In our new house, the electric baseboard heaters were costing a fortune and we were freezing. Our new neighbor installed a furnace in our house, and when our hot



water heater gave out, he put in a new one, only allowing us to pay for the materials. In the summer of 2009, working with this same good neighbor, we took fifteen feral cats to the SPCA spay-neuter clinic, stemming an out-of-control population.

Three generations of the same family has lived across the street from us. Many neighbors remember Jean, who could be seen walking these blocks with her dogs and feeding the birds. One day she told us that her grandson was going to be in a play at Riordan High, so we went to see it. That grandson and his wife now share the family home. Over the last decade, we have made a dear friend in our neighbor who lives behind us on Flood, and we help each other out as we can, as neighbors often will. Another neighbor who volunteers at a community center kitchen from time to time leaves surprise gifts of produce on our porch, and one year around the holidays gave us the best homemade biscotti I've ever tasted.

As I stroll around these streets, I see artfully designed, lovingly tended gardens, many planted with California natives, fronting cozy-looking homes. The beauty around us is also evident in the kindness that people extend to one another. We've made good friends in this place that has become near and dear to our hearts. I am happy to be amongst those who live in a neighborhood that some may have not heard of, but that many have come to call home.


A list of all the blocks where garage sales will be held will be distributed at SNA's August 1 membership meeting.
