Monterey Blvd Safeway Moving Closer Toward Planning Commission

At SNA's February 3 quarterly meeting Natalie Mattei, Safeway Real Estate Manager, updated members on plans for,the Monterey Safeway. Per SF Planning's requests modifications were made to match the motifs of the neighborhood. The side of the store will have large glass windows, vining trellis, and brick. The loading dock door is also brick, with mosaic. Watch for information soon about an exciting community contest for a mosaic design. The roof driveway has grillwork, and the parking lot grillwork has a car headlight shield around its perimeter.

Operating hours should remain the same. An MOU (memorandum of understanding) with SNA is intended to maintain current open hours, from 6 AM to midnight, and only change to 2 AM, (not 24 hours), if future market conditions change and SNA Board and Sunnyside residents want expanded hours. Safeway is about to explore the existing underground utilities, so sidewalk excavation will be taking place. The recycling center will leave to make room for the excavated dirt.

At the Planning Commission Hearing the building permit along with a variance must also be approved to allow the wider driveway to the roof to fit all 3 lanes of cars, one in, two exiting, which is a road diet from the current 4 lanes. Stay tuned for your opportunity to send comments or attend the Commission hearing for the permit.

Balboa Park Station Maintenance Focus of March 25 Community Meeting

The Balboa Park Station, one of the busiest in The City, suffers from poor maintenance and neglect. Anyone who uses the station can attest to its dirtiness. Trash is everywhere, pigeon droppings foul railings and the platform, and the few trash cans usually overflow. Its perimeters landscaped areas are neglected. The surrounding streets are also in disrepair with dangerous potholes. Crosswalk markings are faded with barely visible pavement marking.

At a Community Meeting on March 25 from 6:00-8:00 pm at CCSF Multi-Use Bldg (Phelan near Ocean), Room 140. DPW Director Mohammed Nuru and representatives from SFMTA, SFCTA and BART will outline plans for improved maintenance for the Station area. They will be available to answer questions about priorities for cleaning and landscaping this station that serves thousands of commuters each day. Neighbors are encouraged to attend and insist on regular cleaning, better maintenance, and improved landscaping. Let our public officials know that we care about Balboa Park Station.

We Will Not Forget

On the afternoon of April 10, 2013, Becky Lee, a Sunnyside resident and long time employee at Sunnyside Elementary School, was struck and killed while in the crosswalk at Judson and Edna. The intersection is controlled by 4 way stop signs in all directions. The driver was not cited or arrested.

After months of repeated inquiries to the District Attorney's office, members of SNA's Traffic Committee were informed in mid-January that no charges would be filed. It is the Traffic Committee's impression that the San Francisco District Attorney's office has contributed to the carnage being suffered by pedestrians at the hands of irresponsible driver by once again sending a loud message that enforcement will be lax or non-existent when pedestrian fatalities are involved.

At the special meeting on pedestrian safety at City Hall, of the Police Commission, and the Board of Supervisors'
Neighborhood Services and Safety Committee, on January 16, which all SFPD Command Staff (continued on page 6)

Ocean Avenue Public Plaza Coming Together

The Ocean Avenue Public Plaza advisory committee met on February 6 to receive updates and help plan the next items for the plaza associated with the new low-income housing that has begun construction there. The housing construction is currently on schedule and the Unity Plaza will start construction when the housing is completed. The actual plaza construction could begin this time next year 2015

SFMTA and SFPUC came to an agreement to allow a sculptural element to be installed in the northern corner of Unity Plaza. All concerns related to waterlines traversing the plaza have been addressed and the two agencies are in the process of formalizing the agreement.

A pedestrian connector (stairs, sidewalk, and trees) from the plaza to CCSF is planned as part of the construction. SFMTA has agreed to manage the construction as well as offer five years of maintenance funding to CCSF. Since the connector is on CCSF property, it is CCSF's decision to take on the maintenance long term, which is still pending. If CCSF agrees to maintain the pedestrian connector, the connector will be included in the detailed design package. If not it will be dropped as part of the plaza project.

The committee requested that a pictorial commemorative feature should be incorporated in the detailed design phase of the project. The commemorative piece will provide a sense of place, connection of history and where it is today; themes to consider: "edge of the city, boxing rings, training facilities, horse track". A subcommittee to curate the commemorative feature was created and will provide content suggestions to the plaza committee for review in the coming months. Stayed tuned for more updates.

San Jose Avenue Traffic Calming

SF Municipal Transportation Agency (MTA) held a community meeting in Glen Park on February 3 and presented its plans for a traffic calming pilot road diet project on San Jose Avenue. Working with Caltrans, MTA plans to reduce car speeds on San Jose Ave and the I-280 off-ramp to 35 mph.

Pilot Project modifications planned are:

Phase 1: • Merge the left lane on the current 2 lane Northbound I-280/San Jose Avenue off-ramp with the northbound lane of San Jose Avenue downstream of the existing I-280 tunnel

- Reduce San Jose Avenue to two lanes north of St. Mary's Avenue, then open it up to three lanes just upstream of Randall Street to maintain the traffic calming effect of the road diet. The third lane will reappear briefly as a right-turn pocket onto Mission Street a few hundred feet before Randall Street to avoid a backup.
- Upgrade the San Jose Avenue bicycle lane to a separated bikeway (where space allows), and create a buffered lane with a striped painted area between cars and bicycles.

This road diet is similar to what was successfully done on the southbound lanes of San Jose Avenue from Randall to the entrance to I-280 several years ago. Old timers will remember that the second exit lane on North I-280 was temporarily added after the '89 Loma Prieta earthquake while the double deck freeway of North 280 downtown was closed and rebuilt.

- Phase 2: Maintain Phase I changes on San Jose Avenue
- Merge the two lanes of the existing I-280 off-ramp into a single lane upstream of the existing I-280 tunnel, which then merges with the Monterey Boulevard lane.

Phase 1 started in March and will be evaluated by MTA at the end of October. If, at that time, there is no reduction of speed on the offramp on to San Jose Avenue, Phase 2 will be implemented.

The plan was well received by residents who attended the meeting and there was little or no opposition. Unfortunately, the presentation conflicted with the SNA general membership meeting so Sunnyside was under-represented.

Sunnyside Real Estate

2013 saw major real estate price increases which continue to climb. Median SF house prices now exceed the 2007 peak, due to limited inventory and multiple offers. Increased rents have new buyers realizing it can cost less to buy than rent. Historically SF real estate has a 10 year cycle starting at start of each decade. Moving into the middle of this cycle, prices are expected to peak and level out within the next few years, also affected by interest rates which rose during 2013 from about 4% to current about 4.5%, and forecast to rise another 1% in 2014. attended, Chief Greg Suhr pledged that SFPD officers will now issue citations or arrest motorists at the scene of serious collisions involving pedestrians or bicyclists if the drivers are found to be at fault. The chief also stated that the department will review accidents from the previous 12 months to determine if citations or arrests are warranted.

The Traffic Committee was dismayed by this response, expected more from our public officials and has written to Captain Tim Oberzeir of Traffic Operations, asking that SFPD investigate the accident before the 12-month period cited by Chief Suhr elapses. It is expected and hoped that the driver will be held responsible for her deadly actions on April 10. Captain Oberzeir has directed the lieutenant in charge of the Traffic Collision Investigations Unit to oversee the follow-up we requested. We will keep SNA members informed of further developments.

Lower Speed Limit on Monterey Blvd Proposed

As well as providing access to our neighborhood streets, Monterey Boulevard is used as a freeway on and offramp and can be dangerous, with pedestrians crossing it, and bicyclists and motorists traveling on it. San Francisco Pedestrian Safety Advisory Committee (PSAC) is recommending reducing its speed limit from 35 to 25 miles per hour.

SF PSAC's rationale includes:

- Save Lives. Higher rates of car speed are associated with higher odds of pedestrian deaths (see table below). Slower speeds will help protect all users of the roadway.
- Reducing the Speed Limit Will Not Inconvenience Drivers. Estimates put the level of service impact as minimal, conjecturing about a 45 second increase to travel by car the 2 miles of Monterey Boulevard.
- A Reduced Speed Limit is More Appropriate for this Neighborhood. The area surrounding Monterey Boulevard is residential. Reducing the speed to 25 miles per hour tells drivers that they are passing through a residential neighborhood, with schools, homes and small businesses, and to be aware of pedestrians, bicyclists, children and seniors.

At SNA's November 4 quarterly membership meeting PSAC's proposal was announced, but not voted on. However Sunnyside, Glen Park Elementary and St Finn Barr Schools, and Sunnyside Conservatory have endorsed the proposal. At its November 12 meeting PSAC unanimously supported the proposal and recommended the proposal to Supervisors Norman Yee and Scott Weiner, as well as to SFMTA, which would ultimately vote to change the speed limit.


Relationship of Vehicle Speed to Pedestrian Death

Community Meeting on Balboa Park Station Circulation

Caltrans, SFMTA and BART are studying Balboa Park Station Circulation to reduce conflicts between pedestirans, bicyclists, motorists and public transit at the I-280 freeway ramps while not degrading vehicle operations. On January 30, the Balboa Park Station Citizen Advisory Committee, SFCTA, SFMTA, BART and Caltrans held a community meeting at CCSF on various alternatives proposed for I-280 ramp closures.

- Alternative 1A: Close I-280 southbound off-ramp to Geneva and northbound on-ramp from Geneva . Considered a short-term alternative.
- Alternative 1B: Includes Alternative 1A changes as well as new frontage roads between Geneva and Ocean and would require reconstruction of the Ocean Avenue Bridge over I-280; considered a long-term alternative.
- Alternative 2: Close the I-280 on- and off-ramps at Ocean Avenue, creating a single interchange at Geneva. Community input will be considered as a final report and implementation plan are drafted. He was right. From that spring on, I grew up with the best neighbor one could have. He gave me advice, shared jokes, and made the best sweet potato pie.

Who would have ever guessed that when I became an adult, I would move back to Sunnyside and right across the street from my favorite neighbor. We spent more time sharing stories and sweet potato pie. He watched me become the person I am and when my parents passed, he watched me and made sure I was okay.

Neighbors, for better or for worse, are Sunnyside, and even if the world is about to burst into a new generation, if you're lucky, you can count on them for the better.

This article is dedicated to my dear friend, and neighbor, who passed away at the beautiful age of 99 in February of this year. Thank you, for being a part of my life, and part of Sunnyside.
